David B. Kinney, Democratic Candidate for Congress, Tenth District of Virginia.

David B. Kinney, Democrat of Arlington, Va.; born in Belfast, New York in 1921; graduate of Alma College in Michigan, received his law degree from George Washington University; employed by the National Security Agency for nine years during and following World War II; began law practice in Virginia in 1952; now a Virginia Trial Attorney; former associate judge of Arlington County; senior partner in firm of Kinney, Smith and Barham; member of the America Bar, Virginia State Bar, Virginia Trial Lawyers Association and Arlington Bar; past president of Taylor PTA; served on the School Board Advisory Committee, the Arlington County Health and Welfare Council Committee on the Medically Indigent, Citizens Committee for School Improvement; served on the Committee of 100, and Virginia Advisory Legislative Committee on Insurance Practices Study and Teachers Salary Equalization Study; is a member of the Kiwanis, lives in Arlington with his wife Jean, has two daughters and one son.

Andrew H. McCutcheon, Democratic Candidate for Congress, Eighth District of Virginia.

Andrew H. McCutcheon, born in West Virginia, has lived in Virginia all of his adult life; after Navy service he attended Washington and Lee University and was an honor graduate; reporter and columnist for eleven years; has eight years experience in Washington, working seven years as an Administrative Assistant to Virginia Congressmen J. Vaughn Gary and David E. Satterfield III, one year as Congressional Liaison Officer for Sargent Shriver, OEO. Resides in Fairfax County with his wife, has one daughter.

Div.; following the war became a partner and general manager in a major real estate and building firm in Northern Virginia; served as president of the Arlington County Chamber of Commerce; chairman of the Arlington County Planning Commission; president of the Arlington Optimist Club; member of the American Legion, VFW, DAV, AMVETS, Masonic Fraternity, Loyal Order of Moose, Order of Elks, Order of Eagles, Izaak Walton League, the International Supreme Council of the Order of DeMolay, and Mount Vernon Guard; elected to the 83rd Congress in 1952; reelected to the 84th, 85th 86th, 87th, 88th, 89th, and 90th Col gresses; elected to the Ways and Means Committee in 1964; was reelected to the District of Columbia Committee as a second committee in 1965; resides with his wife in Arlington, Va.; has three daughters.
