#### **Employees Benefit From New Increase In** Health Insurance

Effective 1 January 1979, Melpar employees become eligible for broader coverage in their group health insurance. The broader coverage will include 100% for 360 days in hospital, UCR (Usual Customary and Reasonable) charges for Assistant Surgeon, Consulting Physician fees, Diagnostic (X-Ray and Lab charges), Anesthesiology and Maternity.

The foregoing are all substantial improvements. New to the policy is the up to \$400 for Psychiatric

out-patient charges.

Although insurance costs have risen sharply every year, the employee contribution has not changed in over 10 years. In addition, the new changes will greatly enhance the administration of the plan by the carrier.

## Melpar as I see it:

A few days ago as I was walking to my office, one of our people from Publications came over to wish me well in my new position. I thanked her and said that I would be depending on her to help keep Melpar a success. Her response truly caused me to think. She told me that she would also be depending on me.

I realized that there are now over 700 people depending on Melpar for their livelihood, and the General Manager is responsible for insuring a successful company for all of them. No business decision can be made without considering its impact on our people. If I make a mistake, or don't apply my best efforts in my job, then I'm not living up to my responsibility to you.

Suddenly over 700 people are relying on me to do a good job. This seemed a new responsibility until I realized that while my duties and the scope of my responsibilities have changed over the years, I have always had an obligation to the people with whom I have worked. Even my first job, as an Engineering Assistant, had responsibility. The job didn't seem important to me at the time but in retrospect, it's clear how each individual's job in that organization fit together to form the total product. It is also clear that nowhere could this be more true than at Melpar.

Every person, regardless of his or her job, shares in the responsibility of a successful company for its people. No product that we sell can be successful unless it is designed, manufactured, tested and delivered by responsible professional individuals, backed up by first class support people.

The fact is extremely important because too often in large companies we fail to appreciate how others are depending on us and how we are depending on others in the company. Each person, regardless of his or her job, is an important part of the life blood that keeps Melpar alive and growing. Every individual in Personnel, Finance and Administration, Manufacturing Operations, Systems, Advanced Development, Reliability and Quality Assurance is relied upon by over 700 co-workers at Melpar. No one in this company can truly say that his job or someone else's job is so small or unimportant that it does not matter how well it is done.

As I walk through our plant and see our people, I feel very pleased to have the responsibilities of my job. It gives me an even greater determination to see us surpass our record year of 1978. I hope all of you can feel the same way about your jobs, because as you well know, Melpar is its people and the people are Melpar.



#### Thomas Meloy, Melpar Founder, Dies



Thomas Meloy, 85, founder and former board chairman of Melpar, died on Thursday, January 4th. Melpar was founded in 1946 by Meloy, who coined the name by linking part of his surname with that of his associate, Joseph Parks.

In 1951, the firm was bought by Westinghouse Air Brake Company. Mr. Meloy remained as Melpar president and chairman of the board until 1965.

At the time of his death, Meloy was president of Meloy Laboratories in Springfield. This organization was formerly the research division of Melpar. He was also chairman and chief executive officer of Isomet Corporation, an electronic and optics research and development company.

Mr. Meloy was a graduate of Harvard College, received his engineering degree from the Massachusetts Institute of Technology and studied at the Sorbonne in Paris.

He is survived by his wife Claire, a daughter Mrs. John Nussbaum and a son, Dr. Philip Meloy.

Gary is an ex-Melpar engineer who has been stricken with a rare terminal hereditary ailment, Gardner's Syndrome. He has been hospitalized since November 1976 and although ambulatory, must be fed intravenously. Doctors estimate it will cost about \$20,000 per year for Gary to live at home. His medical insurance does not cover care. The two Cooper children, ages 7 and 9, also suffer from the same hereditary ailment.

As a result of Melpar E-Teamers drive, \$1800 was raised for the Cooper Trust Fund, which was rounded out to \$2000 by a company donation. The Children's Hospital received a total of \$1950. This represents an overall increase of approximately \$1000.

It was the kind of young audience Jan and Captain Woodruff liked — little voices that shrilled back in pleasure and the patter of little palms — the kind of satisfying applause that entertained the entertainers.

There was a tragic note of paradox in the response. These kids showed only delight and appreciation for the lively party and a nice day — and yet would have had every reason to raise their tiny voices in noisy protest. They had been ill-used by life, these abandoned ones who were born out of wedlock or left behind by fugitive fathers. There were mixed blood children whose light hair or foreign features might mean instant social death.

The main thing the Association tries to do is to get the orphans an education, do their best to get them through middle and vocational school, pay their tuition and pick up the cost of their books and uniforms.

#### Melpar Credit Union Reaches Milestone

Since its charter was granted in June 1973, the Melpar Employees Credit Union has grown in size to 341 members with assets of nearly a quarter of a million dollars.

This continued growth has necessitated the hiring of its first paid employee to handle the volume of administrative detail work involved in accepting loan applications and posting employee accounts

Effective December 11th, Peter E. Ferrante began work for the Credit Union during its open hours, 11:45 to 12:45 on Monday and Wednesday. In January the office hours were increased to a daily basis on the same hourly schedule.

1978 Credit Union activity covered 92 loans totalling an excess of \$147,000. Current dividend rate is 6½% per annum.
