## SOLDERING TRAINING STARTING AT FAIRFAX

Experienced solderers from the Production Electronics organization at Fairfax will soon be going back to school.

A course on High Reliability Soldering is scheduled to be taught by assembler group leader, Edith Scarlett, at the Fairfax facility this summer. A training room has been prepared near the assembly area for the High Reliability course.

According to Director of Production Electronics Carty Lawson, Melpar is providing additional training for its employees to attract new business. "Our current soldering methods follow very strict specifications, but many of the contracts we are pursuing require certified high-reliability solderers, so we decided to develop an in-house certification course," said Lawson.

Edith Scarlett, who will be teaching the class, spent 2 weeks at a Department of Defense training course for "High Quality High Reliability Soldering Technology" to become a certified high-reliability soldering instructor. In addition to training the solderers, Scarlett will be instructing the Quality Control inspectors on proper solder joints.

The course at Melpar will be set up in a similar manner to the Department of Defense course which involves making various soldering samples (in class) and classroom briefings on soldering methods and current military specifications. To become certified,

each student will be required to make a perfect solder joint and pass a written exam, as well as keep a file of all of their class work. "A file is established for the benefit of the contractor," explained Scarlett, "it provides the contractor with a reference on the employees' work."

"Our goal in providing this class is to make employees more aware of what kind of work they should be doing," said Scarlett. "One of the advantages of putting employees through a course like this, is that it teaches them how to carefully inspect their own work. This is important because the operating characteristics of the receivers we build require critical parts placement and solder joints."

Scarlett joined Melpar in July of 1986 as an assembler. Her supervisor, Gene Fisher, said "Edith's dedication to work and her ability to get along well with others made her the prime candidate for teaching this course." Scarlett will be recertified to instruct the solderers on an annual basis, depending on Melpar's contract requirements.

### CAFETERIA UPDATE

The final phase of the Falls Church cafeteria remodeling is now underway with the total renovation scheduled for completion by late fall of this year. The new west wing addition will be carpeted by early summer and at that time, will be ready for furniture and plants. This will add to the general ambiance of the new facility. The new area should be open for employee use in late summer.

The major part of the remodeling work has centered upon the reconfiguration of the kitchen for greater efficiency. This involves replacing a major portion of the equipment, some of which has been in service for over 30 years.

Equally important is the upgrading of the food serving lines so that they will be able to handle more customers with better service.

Both of these tasks involve a great deal of pre-planning for the facilities staff. Their main concern is to provide for the continuous operation of the cafeteria, while ensuring that the remodeling work is completely isolated from the food preparation and serving operations. This requires close coordination and cooperation of the in-house facilities staff, outside contractors and vendors, county building and health inspectors, and Marriott Food Service personnel.

In the interim, there may be some inconvenience to employees when various serving areas are temporarily shut down during the rework phases. Please be patient and understand that the facilities staff will try to ensure the work is completed as quickly as possible, with the absolute minimum of interruptions to employee cafeteria services.

When the remodeling is complete, the cafeteria will provide improved accommodations for E-Teamers at the Falls Church plant. **M**

about that technology. These might include technical articles describing the technology, articles describing applications, patents, and product announcements. If you request current awareness service on Acoustic Charge Transport developments, NERAC provides you with periodic updates in the field as developments occur.

To use the services of NERAC, simply call (203) 429-3000. After identifying yourself and the particular request you have, you will be put in contact with a NERAC technical representative that is familiar with your technical area. You will discuss your needs with this representative and 5 to

7 days later, you will receive a package that contains abstracts of those articles, meetings, patents, etc., in response to your request. You can then refine the search with another phone call or request the documents through Sandra Blumberg, our technical librarian.

Feel free to call as often as you like about any technical question that relates to your job here at Melpar. The subscription that Melpar has with NERAC covers all search and update requests for 1 year.

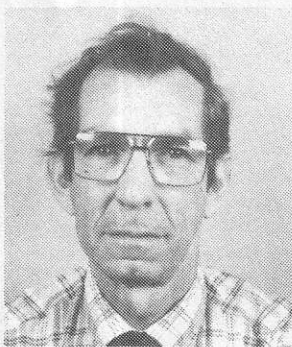
